Special screen trading session for SGX India equity index derivatives on 14 November 2020

1. Special screen trading session on 14 November 2020 (Saturday)

In line with the opening of the underlying cash market in India on account of Muhurat trading on Diwali, the Exchange would like to inform Members that the following contracts will be open for screen trading on 14 November 2020 (Saturday):

- a. SGX MSCI India Index Futures (MD);
- b. SGX MSCI India Net Total Return (USD) Index Futures (NMD);
- c. SGX Nifty Bank Index Futures (INB); and
- d. SGX Nifty 50 Index Futures and Options (IN, CIN, PIN)

(collectively, the "the Contracts").

The Negotiated Large Trade (NLT) facility will <u>not</u> be available on 14 November 2020.
